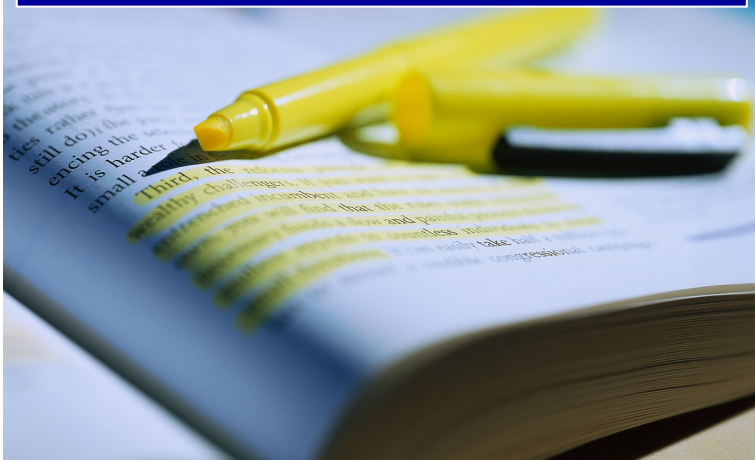


Surplus Line Exam Licensing Class
